- 1. The name of the corporation is ROADWAY MINISTRIES, INC.
- 2. The corporation is a non-profit corporation.
- 3. The period of duration of the corporation is perpetual.
- 4. The purpose or purposes for which the corporation is organized is charitable, religious, missionary, educational, and the transaction of any and all lawful purposes for which non-profit corporations may be incorporated and engaged under the laws of the State of Idaho.

No contributor to this corporation, nor any member of the family of a contributor, nor any corporation controlled by a contributor shall ever derive or receive any financial or pecuniary gain or profit from this corporation on dissolution.
