KNOW ALL MEN BY THESE PRESENTS:

That at a meeting of the Board of Directors of Square Deal Mining and Milling Company Ltd. held on the 13th day of January 1947, a special meeting of the stockholders was called to be convened at the office of the corporation, to-wit: Room 3 Rossi Insurance Building, Wallace, Idaho, on Wednesday the 19th day of February 1947 at two o'clock P. M. for the purpose of considering and acting upon a proposition to change the capital and capital stock of said corporation from \$2,000,000.00 divided into 2,000,000 shares of the par value of \$1.00 each into \$200,000.00 divided into 2,000,000 shares of the par value of ten cents (10) each, that notice of said special meeting of said corporation was given by said corporation through its secretary by the mailing of a copy of the notice of said special meeting to each and every shareholder of said corporation at his last known post office address as the same appears on the records of this corporation.

That said special meeting of said shareholders of said corporation was held at the time and place named and designated in the said notice to shareholders, to-wit: February 19, 1947; that at the date of said special meeting of the shareholders the total voting power of all shareholders of said corporation was 1,093,907 shares; that at said meeting there were present and represented by proxy a total of 858,795 shares of the total voting power of all shareholders of said corporation, being more than two-thirds of the entire voting power of said shareholders of said corporation.

That at said meeting Article VI of the Articles of Incorporation of said Square Deal Mining and Milling Company Ltd., as amended April 28, 1930, was amended by a vote of more than two-thirds of the total voting power of all shareholders of said corporation to read as follows:

ARTICLE VI. That the amount of the capital of said corporation is Two Hundred Thousand (\$200,000.00) Dollars, divided into Two Million (2,000,000) shares of the par value of Ten (10c) cents per share.

That said corporation is financially solvent, and that the foregoing amendment of Article VI does not affect the financial condition of said corporation, and that the proposed reduction of the par value thereof will not reduce the fair value of the assets of said corporation as to an amount of its debts and liabilities plus the amount of the capital stock as so reduced.
