**ARTICLES OF INCORPORATION  
FOR  
U.S. RECOVERY COMPANY, INC.**

The undersigned, acting as incorporators under the corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is U.S. RECOVERY COMPANY, INC.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 2000 shares with no par value.

**FIFTH:** The address of the initial registered office of the corporation is 1407 Arcadia, Boise, Idaho 83705, and the name of its initial registered agent at such address is Gerald R. Paxton.

**SIXTH:** The number of directors constituting the initial Board of Directors of the corporation is two and the names and addresses of the persons who are to serve as Directors until the first annual meeting of shareholders or until successors are elected and shall qualify are:

**TENTH:** The Articles of Incorporation shall not be removed, modified or amended except upon approval of a majority of all of the shareholders at a regular or special meeting of the shareholders called for such meeting.
