If you are incorporating in another state under the same corporation you will need to dissolve your corporation in Idaho. You may do that in one of two ways:

If you wish to formally dissolve your corporation, you must comply with the requirements of Section 30-1-1403, Idaho Code, by filing Articles of Dissolution in duplicate with this office along with the required statutory fee of \$30.00.

Or you may let the corporation administratively dissolve by not filing the corporation annual report form, which I have enclosed (If you wish to file the annual report form, block 2 of the application must be an Idaho physical address.)

The corrected annual report must be received in this office before December 1, 1997 to avoid being subject to administrative dissolution. If you wish to let the corporation administratively dissolve, disregard any future notices you may receive. 

