ARTICLES OF INCORPORATION OF THE BENEWAH HEALTH SERVICES CORPORATION & 6

KNOW ALL MEN BY THESE PRESENTS:

89 SEP 11 AM 9 10

That we, the undersigned, all being of lawful age and being citizens of the United States of America, having associated and do hereby associate ourselves together, for the purpose of forming a non-profit cooperative association, under Title 30, Chapter 3, Idaho Code, governing non-profit cooperative associations and we do hereby adopt Articles of Incorporation as follows:

I.

The name of this corporation shall be the Benewah Health Services Corporation.

II.

The location and post office address of the registered office of the corporation within this state shall be the Valley Vista Care Center, 820 Elm, in the City of St. Maries, County of Benewah and the initial registered agent at such address is Scott Burpee.

III.

The term of existence of this corporation shall be perpetual.

IV.

This corporation does not contemplate pecuniary gain or profit to the members thereof and the purpose for which this corporation is formed is not for profit.

The corporation shall have members, but the management of the affairs of the corporation shall be vested in the board of directors.

VI.

The Benewah Health Services Corporation has been created to promote cooperation and communication between health care providers in the greater Benewah County area, to develop and promote educational inservice opportunities in our area for health care personnel, to recruit qualified health care personnel, to educate the general public regarding the variety and availability of health care services provided by members of the corporation, and to promote greater utilization of those health care services.

VII.

There shall be seven directors on the initial board of directors of this corporation. The directors who will manage the affairs of the corporation until their successors have been duly qualified and selected are as follows:

The name of the incorporator of this non-profit corporation is Scott Burpee whose address is Route 1, Box 277 B, St. Maries, ID 83861.

IX.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article VI hereof.

Х.

The Board of Directors may, from time to time, authorize membership fees to be collected from the members of the Corporation. The amounts of such fees shall be payable at such times or intervals, and upon such notice, and by such methods, as the directors may prescribe.

XI.

Upon liquidation, dissolution or abandonment of the corporation for any purpose, the Board of Directors shall, after paying or making provisions for the payment of all of the lawful liabilities of the corporation, dispose of all of the remaining assets of the corporation to such eleemosynary non-profit organization or organizations as the Board of Directors shall determine.
