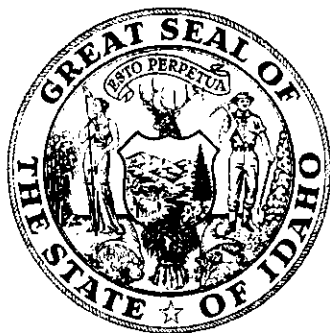

Pursuant to the provisions of Sections 30-1-84 and 30-1-92 of the Idaho Business Corporation Act, the undersigned Corporation adopts the following Articles of Dissolution for the purpose of dissolving the Corporation;




