

ARTICLES OF INCORPORATION  
OF THE  
THUNDER MOUNTAIN GOLD MINING AND DEVELOPMENT COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned, ~~Joseph~~ Pinkham, C. S. Loveland, Fremont Wood and S. E. Burnham, of Boise City, Ada County, Idaho, and Thomas B. Ryan of Pearl, Boise County, Idaho, have this day associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we do hereby certify:

1st.-

That the name of said corporation is the Thunder Mountain Gold Mining and Development Company, Limited.

2nd.-

That the purposes for which this corporation is formed are as follows: For carrying on a general mining business in the State of Idaho and in any other state or territory of the United States; for the purpose of purchasing, bonding or contracting for the purchase of mines and mining claims and for the development, operation and working of the same, and generally to do all things necessary in, about or pertaining to said business, including the selling and treatment of ores; for the construction of roads, flumes, ditches bridges and erections of every kind necessary to the operation of mines and for the construction of the buildings necessary for the mining, milling or treatment of ores, including the construction of store buildings for supplies; for the purpose of selling and conveying any mines or interests in mines or mining property belonging to this corporation; for the purpose of buying and selling supplies of every kind and description used in, about, or in connection with said mining business and for the purpose of operating such retail stores as may be necessary or convenient in or about the mines of the company or in the vicinity thereof. Said mining

operations may extend to all valuable minerals of every description, and it is particularly intended by said incorporation to commence operations by purchasing the Black Jack and Independent lode claims in Thunder Mountain Mining District, Idaho County, State of Idaho, and thereafter provide for the development and operation of the same.

3d.-

That the place where its principal business is to be transacted, shall be Boise City in the County of Ada, State of Idaho; that the principal office shall be at the said Boise City.

4th.-

That the term for which this corporation shall exist is fifty years from and after the date hereof.
