### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

**HELBLING BROS., INC.**

was filed in the office of the Secretary of State on the **Twenty-third** day of **February** A.D. One Thousand Nine Hundred **Sixty-one** and duly recorded on Film No. **113** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **Seventy-five years existence** from the date hereof, with its registered office in this State located at **Moscow** in the County of **Latah**.

ARTICLES OF INCORPORATION OF

"HELBLING BROS., INC."

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, each being natural persons of full legal age and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

FIRST

That the name of said corporation shall be:

"HELBLING BROS., INC."

SECOND

That the existence or duration of said corporation shall be for the term of seventy-five (75) years.

THIRD

That the purposes for which said corporation is formed are to carry on the trade of a dealer in agricultural machinery, implements and tools, and any and all other articles pertaining to agriculture, and to purchase, rent, lease, hypothecate, and to sell at wholesale and retail, and in general to deal in implements, machinery, vehicles, and any and all articles pertaining to farm operations and agriculture, in any or all of the states and territories of the United States and in foreign countries, and to acquire property for the purpose of carrying on such business; to do the

same with all kinds of vehicles, including watercraft and aircraft, as well as hardware, appliances, gas, oil, and other fuels and components of energy; to buy and sell on commission or otherwise all kinds of farm produce; to own real and personal property and to buy, sell, lease, and hypothecate real and personal property; to purchase, own, operate, and develop farms, farm lands, stock farms, and grazing and timber lands, and to buy, raise, sell, or otherwise deal in cattle, hogs, and all kinds of livestock; to buy, sell, trade, rent, lease, and deal in, at wholesale or retail, hardware, appliances, machinery and goods, wares and merchandise of all kinds for farm and home use; to buy, sell, rent, lease, and hypothecate and otherwise deal in logging machinery and equipment, as well as all kinds and types of road or other construction equipment, tools, materials and appliances; to do all legal, necessary and proper things in pursuance of the foregoing stated objectives and purposes.

#### FOURTH

That the location and postoffice address of the registered office of said corporation shall be Moscow, Latah County, Idaho.

#### FIFTH

That the capital stock of this corporation shall be Five Hundred Thousand Dollars (\$500,000.00) divided into fifty thousand (50,000) shares of common stock of the par value of Ten Dollars (\$10.00) each.

SIXTH

That the number of directors of said corporation shall be four (4), who must be shareholders of common stock of said corporation. That said directors shall be elected by the shareholders of said corporation. That at the meetings of the shareholders of said corporation cumulative voting shall be permitted.

SEVENTH


