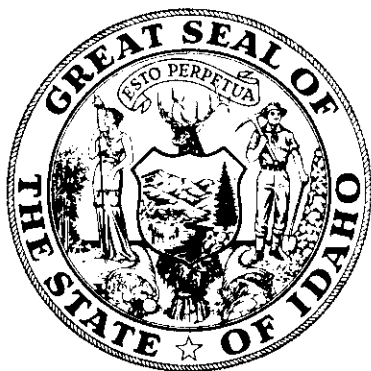

ARTICLES OF INCORPORATION
OF
ED'S MASONRY AND CONSTRUCTION INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being a natural person of legal age and acting as incorporator of a corporation, under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the Corporation is Ed's Masonry and Construction Inc.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are: transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is fifty thousand shares (50,000) with a par value of One Dollar (\$1.00) per share. There shall be one class of shares, all of which shall be common shares.

FIFTH:

The address of the initial registered office of the corporation is 3320 Molen Street, Idaho Falls, Idaho 83401, and the name of the initial registered agent at such address is Etsel E. Sommer.

SIXTH:
