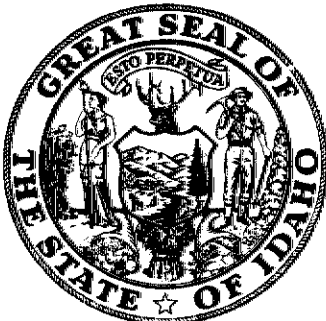

ARTICLES OF INCORPORATION  
OF  
RAINMAKER LANDSCAPE, INC.

The undersigned, acting as incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

1. **NAME.** The name of the coporation is: RAINMAKER LANDSCAPE, INC.
2. **DURATION.** The period of its duration is perpetual.
3. **PURPOSES.** The purpose for which the corporation is orgainized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
4. **STOCK.** The corporation shall have the authority to issue 10,000 shares of capital stock, all of one (1) class, \$1.00 par value.
