CERTIFICATE OF INCORPORATION

I, J. D. (CY) PRICE, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of **THE APOSTOLIC CHURCH OF LEWISTON, IDAHO**

was filed in the office of the Secretary of State on the **Seventeenth** day of **December** A. D. One Thousand Nine Hundred **forty-eight** and is duly recorded on Film No. **15** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 29-103, 29-1101 and 29-1102, Idaho Code, Annotated.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **Perpetual existence** from the date hereof, with its registered office in this State located at **Lewiston** in the County of **Nez Perce**, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29, Idaho Code, Annotated.

Done at Boise City, the Capital of Idaho, this **seventeenth** day of **December**, in the year of our Lord one thousand nine hundred **forty-eight**, and of the Independence of the United States of America the One Hundred **Seventy-third**.

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are members of The Apostolic Church of Lewiston, Idaho, do hereby associate ourselves together for the purpose of forming a religious corporation under the laws of the State of Idaho in accordance with provisions of Chapter 11, Title 29, Idaho Code Annotated, and all laws supplemental thereto and amendatory thereof, and we do hereby adopt the following articles of incorporation, viz:

ARTICLE I.

The name of this corporation shall be

THE APOSTOLIC CHURCH OF LEWISTON, IDAHO, INC.

ARTICLE II.

That the objects and purposes for which this corporation is formed are:

- (a) To establish a church wherein the members of this religious body may meet for christian worship in the manner prescribed by the tenets of said church.
- (b) To purchase, lease or otherwise acquire, own, hold, manage, sell, lease, mortgage or otherwise dispose of real and personal property of every kind, nature and description, but said corporation shall not own or hold more real estate than is at any time necessary for the business and objects of the corporation.
- (c) To receive donations and to receive, manage, take and hold real and personal property by gift, grant, demise or otherwise for the purposes herein specified.
- (d) To do everything necessary, convenient or proper to be done in carrying out the foregoing enumerated purposes in their fullest and broadest sense without object of profit to the members of said corporation.
- (e) Precuniary profit is not the object of this corporation. The existence of this corporation shall be perpetual.

ARTICLE III.

The place where the principal place of business of said corporation shall be located and its registered office maintained, shall be in the City of Lewiston, County of Nez Perce, State of Idaho.

ARTICLE IV.

This corporation is organized without capital stock and no stock of any kind or nature has been or shall hereafter be issued by said corporation.

ARTICLE V.

That the directors of said corporation shall consist of three (3) members to be elected at the annual meeting of said corporation; provided, however, that said number may be increased to five (5) or more by a two-thirds (2/3) affirmative vote of all members in attendance at any annual meeting voting upon such question.

ARTICLE VI.

That the annual meeting of said corporation for the election of directors and transaction of all other business of said corporation shall be held on the first Tuesday of December of each year at the hour of 7:30 o'clock P.M. at the registered office of said corporation in Lewiston, Idaho; that no notice of the annual meeting shall be required.

ARTICLE VII.

That a meeting of the members of The Apostolic Church of Lewiston, Idaho, was duly had and held at the church building, 417 2nd Avenue, Lewiston, Idaho, on the 9th day of December, 1948, for the purpose of forming this corporation and electing directors thereof; that notice of said meeting was given in the form attached hereto by the posting of a copy thereof in a conspicuous place on the building where such meeting and election was to be held and by publication of said notice for at least two weeks in the Lewiston Morning Tribune, a newspaper of general circulation in and printed and published in the City of Lewiston, Idaho.

ARTICLE VIII.

That at said meeting, the following were elected as directors of said corporation to serve until the next annual meeting, and until the

election and qualification of their successors.


