These ARTICLES OF AMENDMENT are made as of July 11, 1997, by TRI-STATE BANK, an Idaho corporation, with its main office in Montpelier, Idaho ("Tri-State Bank"), pursuant to the requirements of Idaho Code § 30-1-1006.

**ARTICLE ONE**

The name of the corporation is Tri-State Bank.

**ARTICLE TWO**

Articles First and Fifth of the Articles of Incorporation of Tri-State Bank are amended to read in their entirety as follows:

"FIRST: That the name of this corporation is ZIONS BANK."

"FIFTH: That the total authorized capital of this corporation shall be \$1,500,000, divided into 120,000 shares with a par value of \$12.50 per share. All stock shall be common stock. Each share of stock shall be entitled to one vote."

**ARTICLE THREE**

The amendments to the Articles of Incorporation of Tri-State Bank set forth in Article Two hereof (the "Amendments") were adopted by the shareholders of Tri-State Bank at a special meeting of shareholders held on July 11, 1997.

**ARTICLE FOUR**

The number of shares of stock outstanding of Tri-State Bank, the number of shares entitled to vote with respect to the adoption of the Amendments and the designation of shares entitled to vote as a class with respect thereto, are set forth below:




