**ARTICLES OF INCORPORATION**

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned incorporator being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of Incorporation.

**ARTICLE I**

The name of the corporation is **MOVIELAND VIDEO, INC.**

**ARTICLE II**

The period of its duration is perpetual.

**ARTICLE III**

The purposes for which the corporation is organized are as follows:

- (a) To conduct the business of general merchandising services for a retail sales establishment;
- (b) To do all other things necessary or incidental to the foregoing business purposes;
- (d) To undertake all other business activities of any kind or nature for which businesses may be lawfully incorporated under the laws of the State of Idaho;

**ARTICLE IV**

The corporation is authorized to issue one class of shares, in a total amount of One Thousand (1,000) shares. The stock shall bear no par value. Shares of stock of this corporation

shall not be transferred or sold until said sale shall be approved by the Board of Directors of this corporation, in accordance with the duly adopted By-Laws of this corporation.

The capital stock of this corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.

#### ARTICLE V

The address of the initial registered office of the corporation is 135 South Rail West, Shoshone, Idaho 83352.

The name of the initial registered agent at such address is CAROLE EVANS.

#### ARTICLE VI


