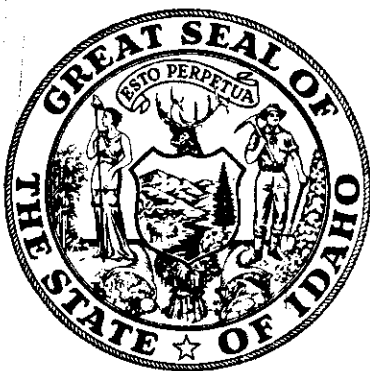

Pursuant to Idaho Code 30-1-59, 30-1-61, and 30-1-145, the undersigned hereby certify:

1. That they are the owners and holders of all 250 shares of no par stock of Jensen-Wood Motor Company.


2. That there is no other class of stock issued by the corporation.


3. That the following Resolution was adopted by the unanimous vote of the holders of all 250 shares of said stock on the 28th day of February, 1989:

f. To act as an agent for insurance companies in soliciting, procuring, receiving and forwarding applications for property, casualty, life and accident and health, credit life, and all kinds of insurance, together with the collection of premiums and the doing of such other business as may be designated to agents by insurance companies and to conduct a general insurance agency and insurance brokerage business, and to do any and all things incidental to the operation of an insurance agency which is not forbidden by statute or by these articles of incorporation."

4. The undersigned hereby give their written consent to the adoption of the foregoing Amendment to Articles of Incorporation without the need of a formal meeting.
