

The undersigned, whose names are hereto subscribed, for the purposes hereinafter stated, do hereby associate ourselves into a body corporate under the provisions of Title 30 Chapter 3 of the Code of Idaho (commonly known as the Idaho Nonprofit Corporation Act), assuming all the powers and obligations granted bodies corporate under said act and do hereby adopt, execute and acknowledge the following Articles of Incorporation, to-wit:

ARTICLE I

The name of this corporation shall be Resources for the Blind of Idaho, Inc.

ARTICLE II

This corporation shall be a nonprofit corporation according to Title 30 Chapter 3 of the Idaho Code and Section 501(c)(3) of the IRS Code.

ARTICLE III

The period of duration of this corporation shall be perpetual.

ARTICLE IV

The general purpose of this corporation and its plan of operation shall be as follows:

The object for which this corporation is formed is the receipt of gifts and devices to be used for the advancement of and to promote the welfare of blind people; the acquisition for such use and purpose of such real and personal property as may be donated to the corporation from time to time and all things necessary or incident to the accomplishment of the foregoing purposes, provided, however, that none of the funds, property or income of the corporation shall be used in attempting to influence legislation by the carrying on of propaganda or otherwise or for the benefit of any private member of the corporation or individual. To accomplish the foregoing object or purpose, this corporation shall have the right to act as trustee of any funds or property that it may receive under specific or limited gifts, grants or agreements or that it may receive by testamentary disposition and shall have the right to hold and manage the same under the terms and conditions imposed by any such bequest not inconsistent with the objects hereinabove expressed. To have and exercise all of the powers granted to corporations not for pecuniary profit under the laws of the State of Idaho.

ARTICLE V

This corporation shall have bylaws for the government, control and direction of the business of the corporation, its officers, directors and committees. Said bylaws initially shall be the constitution drafted by the Executive Committee of Resources for the Blind of Idaho, April 13, 1996. These bylaws may be amended in the manner provided therein.

ARTICLE VI

The bylaws of this corporation may establish classes of members.

ARTICLE VII

The annual meeting of this corporation shall be as the regular Board Meeting held during the second quarter of each year.

ARTICLE VIII

The address of the initial registered office of this corporation shall be 350 N. 9th Street, Suite B-80, Boise, Ada County, Idaho, 83702. The initial registered agent of this corporation shall be Kyrsten Bell.

ARTICLE IX

The initial Board of Directors of the corporation shall be as follows: President, Jan Gawith, 410 Avenue H, Boise, ID, 83712; 1st Vice-President, Larry Streeter, 1375 Hancock, Boise, ID, 83706; 2nd Vice-President, Mary Ellen Halverson, 3013 Agate, Boise, ID, 83705; Secretary, Brett Winchester, 8373 Chinden Boulevard, Boise, ID 83714; Treasurer, Ramona Walhof, 1301 S. Capitol Boulevard, Suite #C, Boise, Idaho, 83706; Board Member, Randall Pirnie, 686 S. Skyline, Idaho Falls, ID, 83402. These individuals shall serve for two years. Additional Board Members may be elected at any regular, quarterly meeting. Election of officers shall be every two years during even-numbered years at the annual meeting as specified in the bylaws.

ARTICLE X

The incorporator of the Corporation shall be Jan Gawith, 410 Avenue H, Boise, ID, 83712.

ARTICLE XI

In the event of dissolution of the Resources for the Blind of Idaho, Inc., or if for any reason it ceases to exist, its assets shall be disbursed in the following manner:

- A. Recent contributions shall be returned to the givers.
- B. Assets which cannot be returned to the donors shall be contributed to the National Federation of the Blind of Idaho.
