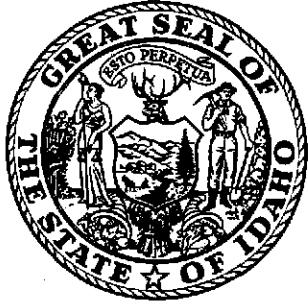

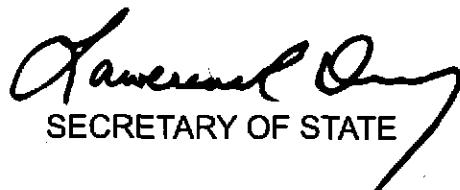
CORPORATION REINSTATEMENT CERTIFICATE
