The undersigned, being a duly licensed engineer, qualified to practice engineering pursuant to the laws of the State of Idaho, in order to form a professional corporation for the purposes hereinafter stated, pursuant to the Professional Service Corporation Act and Idaho Business Corporation Act, does hereby adopt the following Articles of Incorporation for such corporation.


