ARTICLES OF INCORPORATION

OF

LLOYD LUMBER COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, whose names are hereto subscribed, being natural persons of full age and citizens of the United States of America, hereby associate ourselves into a body corporate under the provisions of the laws of the State of Idaho, assuming all the powers, rights and privileges granted bodies corporate under said laws, and we do hereby make, adopt, and file these Articles of Incorporation, hereby declaring and certifying that the facts stated herein are true, to-wit:

FIRST: That the name of this corporation is:

LLOYD LUMBER COMPANY, INC.

SECOND: That the purposes for which this corporation is formed, are:

- (1) To carry on a general merchandising sales and service business in the State of Idaho, the United States or any foreign country.
- (2) To, among other things, buy, sell, hold, rent, service, manufacture, wholesale and retail merchandise of every kind and nature including specifically among other things, lumber, coal, fuel oils, paint, hardware and building materials of every kind and nature.
- (3) To make and enter into any and all kinds of contracts, agreements and obligations by and with any person or persons, corporation or corporations for the purchasing, acquiring, holding, manufacturing and selling or otherwise disposing of either as principal or agent, upon commission or otherwise, goods of all kinds, and any article of personal property whatsoever.
- (4) To make and carry out any contract, and to do any act and exercise any power which a co-partnership or individual person

anywise changing any and all of its rights, properties, real or personal, privileges and franchises.

(11) To buy, hold, own, or otherwise acquire, pledge, sell, or otherwise dispose of shares of capital stock or bonds of this corporation; to do each and every thing it may deem necessary for the carrying on of its business and not specifically in conflict with the laws of the State of Idaho, relative to corporations.

(12) To buy, purchase, or otherwise acquire any other merchandising establishment and equipment and machinery for equipping the same, or to sell the same or any part thereof.

(13) To do each and every thing necessary, suitable or proper for the accomplishment of any or the purposes of attainment of any one or more of the objects herein enumerated, or which, at any time appear conducive or expedient for the protection or benefit of the corporation.

SECOND: That the term for which this corporation shall exist, is unlimited and perpetual.

THIRD: That the place of the principal business of this corporation shall be at Lava, in the County of Canyon, State of Idaho, and that the registered office of said corporation shall be located at Jerome, Canyon County, Idaho.

FOURTH: That the total authorized number of par value shares of said corporation shall be forty thousand (40,000) shares, of the par value of ten dollars (\$10.00) each, and the aggregate par value shall be four hundred thousand dollars (\$400,000.00).

FIFTH: That all the said shares of stock shall be common Stock, and each share of stock shall be entitled to one vote.

SEVENTH: That the following are the names and post office addresses of each of the incorporators, to-wit:

could lawfully do and exercise so far only as may be necessary or proper for carrying out the purposes for which this corporation is organized, and generally with full power to do and perform any and all acts connected therewith or arising therefrom or incident thereto, and any and all acts proper or necessary for the purposes of the business; but the corporation shall not do any act or thing forbidden by law to a corporation organized under the laws of this State.

(5) To own, operate and equip in connection with its said business, a complete establishment; to care for and repair all goods and materials by hand or by the use of machinery and mechanical instruments, implements and appliances, and by application of skilled manual labor and operations.

(6) to keep in storage, or otherwise, all kinds of merchandise including among other things, all kinds of lumber, coal, fuel oils, paint, hardware and building materials of every kind and nature.

(7) To purchase, erect, construct, lease, own, or otherwise acquire, real and personal property, including stocks and bonds of other corporations of every kind and nature, for investment purposes or otherwise, which its Board of Directors may deem necessary for the successful operation of its business.

(8) To own, purchase, or otherwise acquire, all manner of motor vehicles, machinery and equipment for the successful operation of its business, and which said corporation may deem necessary.

(9) To make and execute contracts with individuals, partnerships and corporations for the exclusive use of its property, and to purchase, control and use individual rights, easements and contracts, and to make contracts for its services and facilities.

(10) To borrow money for the successful management of its business, and in pursuance of such power, to issue bonds, debentures, notes, mortgages and other evidence of indebtedness and obligations and to secure the payment of the same by mortgaging, pledging or in
