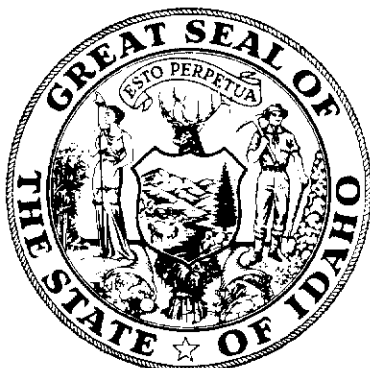

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is IDAHO PROPERTIES REAL ESTATE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000, \$1.00 par value.

FIFTH: There are no provisions denying preemptive rights. All shares of stock authorized are of the same class, common stock shares.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are the By-Laws of the corporation.

SEVENTH: The address of the initial registered office of the corporation is 326 N. Orchard, Boise, Idaho and the name of its initial registered agent at such address is Elden E. Gray.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is four (4), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
