We, the undersigned, Robert G. Thomas, President, and Doris Johnson, Secretary, of the Church of the Nazarene, Inc., Coeur d'Alene, a corporation organized and existing under and by virtue of the laws of the State of Idaho, do hereby certify as follows:

That at a meeting of the members of said corporation, held on the 25th day of May, 1955, at Coeur d'Alene, County of Kootenai, State of Idaho, pursuant to notice as to time and place, a copy of said written notice of said meeting together with affidavit of publication of said notice being on file in the record book of said corporation, and said meeting being a special membership meeting, the following Resolution, to-wit:

"BE IT RESOLVED that ARTICLE VI. of the Articles of Incorporation of Church of the Nazarene, Inc., Coeur d'Alene be amended, changed and altered to read as follows:

" VI.

The corporate powers of this corporation shall be vested in a Board of Directors consisting of not less than three (3) or more than nine (9) members and to be of a number as prescribed by the By-Laws of this corporation and to be elected as provided in said By-Laws. To be a director, a member must be in good standing of the Church of the Nazarene, Inc., Coeur d'Alene. The powers and duties of the officers of this corporation shall be prescribed in the By-Laws."

was moved for adoption, duly seconded and thereafter voted upon by the members present at said meeting, and said members represented a majority of the membership of said corporation, and the said Resolution was unanimously carried.
