

ARTICLES OF DISSOLUTION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned being natural persons of full age, citizens of the United States and residents of the State of Idaho, this day have voluntarily associated ourselves together for the purpose of dissolving a corporation under and pursuant to the laws of the State of Idaho, section 30-1-92 and we do hereby certify as follows:

ARTICLE A.

Upon execution of the Resolution to Dissolve, all remaining property, assets of the corporation have been distributed among the shareholders in proportion to their respective rights and interests.


ARTICLE F.

As of the execution of the Resolution to Dissolve, there are no suits pending against this corporation in any court.


ARTICLE G.
