We the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under the Idaho Religious, Social and Benevolent Corporation Act adopt the following articles of incorporation for such corporation:

The name of the corporation is the Lutheran Campus Council at the University of Idaho, Incorporated.

The period of duration is 50 years.

The purposes for which the corporation is organized is:

to serve as functioning unit for the Division of College and University Work of the National Lutheran Council (Division of College and University Work of the National Lutheran Council herein after referred to as the Division).

The members of the corporation shall be members of the American Lutheran Church and the Lutheran Church in America and shall be selected as stipulated in the hy-laws.

The manner in which the directors are to be elected is stipulated in the by-laws.

Provisions for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets of dissolution or final liquidation, are vested in a Council consisting of not less than six (6) nor more than twelve (12) members, which shall be its governing body and shall have the authority to conduct, manage and control the affairs of the corporation, and to make rules for the guidance of the officers and the orderly conduct of the affairs of the corporation. On dissolution of the corporation all assets will revert to the Division or its successor or assigns.

Two weeks previous notice has been published concerning the meeting to incorporate, (attached).

The address of the initial registered office of the corporation is 822 Elm St., Moscow, Idaho, and the name of its initial registered agent at such address is Dr. Duane LeTourneau.
