ARTICLES OF INCORPORATION  
of  
Discovery Christian Dayschool, Inc.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **DISCOVERY CHRISTIAN DAYSCHOOL, INC.**

SECOND: The corporation is formed exclusively to provide Biblically-based Christian Education and training, and child care, and to carry out any other activity for an exempt purpose as set out in section 501(c)(3), Internal Revenue Code. The corporation is specifically prohibited from engaging in conduct for a purpose which is not exempt under section 501(c)(3), Internal Revenue Code.

THIRD: All assets of the corporation are hereby dedicated exclusively to activities carried out for any exempt purpose under section 501(c)(3), Internal Revenue Code.

FOURTH: Upon dissolution, the assets of the corporation shall be distributed for use to carry out an exempt purpose under section 501(c)(3), Internal Revenue Code, or shall be distributed to another organization or organizations which carry on activities pursuant to an exempt purpose under section 501(c)(3), Internal Revenue Code, which purpose shall be as nearly as possible the same purpose for which this corporation was formed.



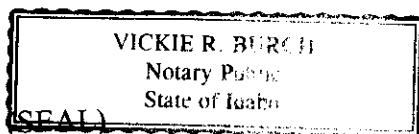
