ARTICLE I. NAME

The name of the Corporation shall be Bristol Bay Sportfishing, Inc.

ARTICLE II. PERIOD OF DURATION

The period of existence and duration of the life of this Corporation shall be perpetual.

ARTICLE III. PURPOSES

This Corporation is organized for the purpose of providing guided fly out sportfishing and hunting in the State of Alaska and to provide lodge and outfitting services for the Corporation's clientele. The Corporation is further organized for the purposes of leasing, managing and operating the Talarik Creek Lodge in Iliamna, Alaska by providing overnight rooms and food to the clientele.

The Corporation is further organized for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
