To make and alter By-Laws of this corporation, to fix the amount to be reserved as working capital

over and above its capital stock paid in, and to authorize and cause to be executed mortgages and liens upon the real property and personal property of this corporation.

(2) Pursuant to the affirmative vote of the holders of at least a majority of the stock issued and outstanding, having voting power, when authorized by the written consent of at least two-thirds (2/3) of a majority of the holders of the voting stock issued and outstanding, the board of directors shall have the power and authority at any meeting to sell, lease or exchange all of the property and assets of this corporation, including its goodwill and corporate franchise, upon such terms and conditions as its board of directors deems expedient and for the best interests of the corporation.

SIXTH: <u>Capital Stock</u>: The capital stock of this corporation shall be Ten Thousand (\$10,000) divided into 100 shares of stock at par value of One Hundred (\$100.00) per share.
