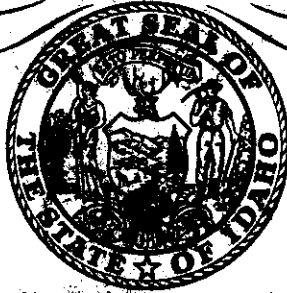

I.

The name of this corporation shall be Beautify Bonneville Council, Inc.

II.

This corporation is organized under the provisions of Chapter 10, Title 30, I. C.

III.

The purposes of this corporation are:

2. To pursue an educational program in all areas pertaining to beautification.
3. To consolidate and coordinate with interested businesses, agencies and organizations for promoting city-county beautification.
4. To serve as an advisory council on pertinent problems pertaining to city-county beautification.
5. To develop Beautify Bonneville projects decided on a priority basis by the council members.
