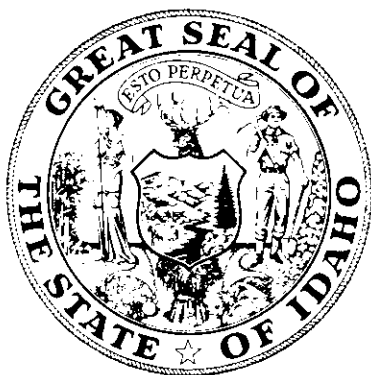

All remaining property and assets of the corporation have been distributed among the shareholders in proportion to their respective rights and interests.

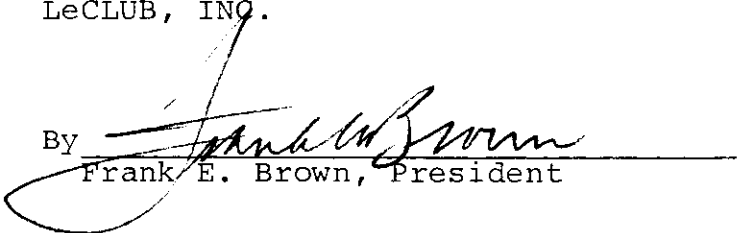

There are no suits pending against the corporation in any court.

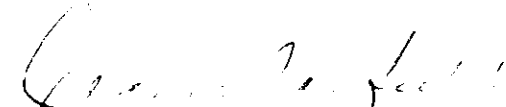

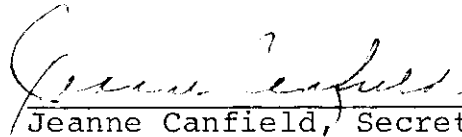
CERTIFICATE OF CORPORATE SECRETARY
