AMENDMENTS TO ARTICLES OF INCORPORATION

of

RECENTED SEC. OF STATE

PEOPLE-PET RELATIONSHIPS, INC. 17 AM 9 06
This amendment was passed by unanamous vote on August 1,
1990 at a special meeting called by the President. A quorum
of the membership was present.

Article XI

This orginization is organized exclusively for charitable and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

Notwithstanding any other provisions of these articles the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future tax code), or shall be distributed to the Federal Government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office

of the corporation is then located, exclusively for such purpose or to such orginization or orginizations, as said Court shall determine, which are orginized and operated exclusively for such purpose.
