ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is LOGGER'S SERVICES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the Corporation is organized is to provide payroll and personnel services to the logging and other industries together with all related activities and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
