### ARTICLES OF INCORPORATION

OF

IDAHO SALERS ASSOCIATION, INC.

We, the undersigned, desiring to form a non-profit corporation under the statutes of the State of Idaho, do hereby make, subscribe and acknowledge as follows:

#### ARTICLE ONE

#### NAME

The name of the corporation is IDAHO SALERS ASSOCIATION, INC.

#### ARTICLE TWO

### NON-PROFIT PURPOSE

This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code. No part of the corporate assets, income or profit shall be distributable to, or inure to the benefit of its officers, directors or members, except to the extent permitted for a non-profit corporation under the non-profit corporation laws of the State of Idaho and under Section 501(c)(3) of the Internal Revenue Code. The corporation shall not take steps which serve to facilitate the transaction of specific business by its officers, directors or members; or promotes the private interest of any officer, director or member; or engage in any activity which would constitute a regular business of a kind ordinarily carried on for profit.

#### ARTICLE THREE

# PURPOSE

The purpose of the corporation is the development and promotion of the Salers breed of cattle in Idaho. The Salers breed is defined as those cattle developed for centuries in Central France with the Salers Herd Book established in 1906.

### ARTICLE FOUR

#### DURATION

The period of duration of this corporation is perpetual.

#### ARTICLE FIVE

### MEMBERS

There shall be one (1) class of members. The conditions and regulations for membership and the rights and other privileges of membership shall be determined and fixed by the Bylaws.

# ARTICLE SIX

# ARTICLE EIGHT

# DISTRIBUTION ON DISSOLUTION OR LIQUIDATION

In the event of the liquidation or dissolution of the corporation, whether voluntary or involuntary, no officer, director or member shall be entitled to any distribution or division of its remaining property or its proceeds; and the balance of all money and other property received by the corporation from any source, after the payment of all debts and obligations of the corporation, shall be used or distributed exclusively for the purposes set forth in Article Three; and further upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established

its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

These Articles of Incorporation may be amended from time to time in any manner lawful under the Non-Profit Corporation Act of the State of Idaho.
