After the under-
signed being desirous of forming
a Corporation for the purpose of
Mining Milling and Smelting under
and in pursuance of the laws
of the Territory of Idaho do hereby
certify and declare as follows:
First that the said
corporation shall be known by
the name of the "Cajon Mining and
Reduction Company"
Second That the object
of said Corporation shall be to
carry on and conduct the busi-
ness of mining and reduction
of ores and extracting metals of
gold silver and copper from those
certain veins or lodes known by
the following names viz: Cajon, Blue
Stolon and East Fraction mines and
the Amaron, Butario and other mines
in Centelpe Mining District Alturas
County Idaho Territory and also the
buying and selling of mines in
said Territory and for acquiring
such real and personal estate as
may be necessary to carry on the
above described undertaking.
Third That the
amount of the Capital stock of said




1 Corporation shall be one million
2 (1,000,000) dollars which shall be divided
3 into one hundred thousand (100,000)
4 shares of the nominal value of ten
5 dollars each provided however that
6 the Capital Stock of said Company
7 may be increased by a three
8 fourths of stockholders at a special
9 meeting held for that purpose to
10 two (2,000,000) millions of dollars,
11 divided into two hundred (200,000)
12 thousand shares of the nominal value
13 of ten dollars each but there shall be
14 no further increase thereafter of the
15 Capital stock of said Corporation.

16 Fourth. That the said
17 Corporation shall exist for the term
18 of Fifty years.

19 Fifth. That the principal
20 place of business of said Corporation
21 shall be in the town of Era, Cullinas
22 County Idaho Territory for the first
23 three months of its organization but
24 the principal place of business of
25 said Corporation may be changed
26 to Salt Lake City Utah Territory or
27 town of Hailey Idaho Territory by
28 vote of the Directors of some owning
29 two thirds of the Capital stock of said
30 Corporation.


