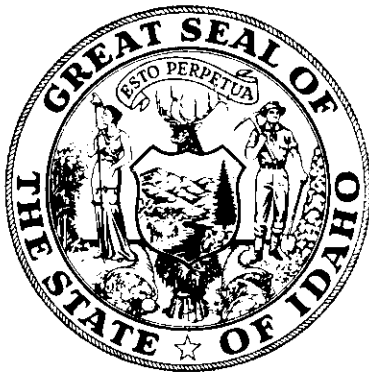

ARTICLES OF AMENDMENT

to the

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Springer Insurance Agency, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on April 15, 1981, in the manner prescribed by the Idaho Business Corporation Act:

Article THIRD of the Articles of Incorporation, be, and the same are hereby amended to read as follows, to-wit:

"THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act,

including, but not limited to, engaging in the business selling, soliciting, or brokering property, casualty, life, or disability insurance; or acting as an insurance agent, broker, or consultant in the State of Idaho and the State of Washington; to solicit applications for insurance or annuity contracts or to negotiate for such contracts on its behalf, and if authorized to do so by the insurer, to effectuate, issue and countersign insurance contracts; and to carry on the business usually done by general insurance agencies in the State of Idaho and State of Washington."

THIRD: The number of shares of the corporation consist of one class only, and the shares outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote thereon was 1,000.

FOURTH: The number of shares voted for such amendment was 1,000, and the number of shares voted against such amendment was zero.

FIFTH: There is no exchange, reclassification, or cancellation of issued shares provided for in the amendment.

SIXTH: There is no change in the amount of stated capital.
