# ARTICLES OF INCORPORATION OF

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, OWEN F. KOLLER, GERALDINE R. KOLLER and DONALD H. KLAGES, each of whom is over the age of twenty-one years, and each of whom is a citizen of the United States of America and a resident of the State of Washington, having associated themselves together for the purpose of forming a corporation under the laws of the State of Washington, and in pursuance thereof, do hereby sign and acknowledge the following Articles of Incorporation, in triplicate originals, and do state as follows:

#### ARTICLE I

The name of the corporation shall be FARM AND BUSINESS REALTY, INC.

#### ARTICLE II

The purposes of this corporation are as follows:

- l. To conduct a general brokerage, agency and commission business for themselves and for others, in the purchase, sale and management of real estate for themselves and for others, and the negotiation of loans thereon; to purchase and sell for themselves and for others, personal property, stocks, bonds, and notes, and to negotiate loans thereon for themselves and for others; to act as trustee in deeds, mortgages or real estate contracts on real or personal property, or any evidence of value to secure them, and to act as agents for letting houses, lands, and the collection of rents and the payment of taxes.
- 2. To acquire by purchase or lease, or otherwise, lands and interest in lands, and to own, hold, improve, develop and manage any real estate so acquired, and to erect or cause to be erected on any lands owned, held or occupied by the corporation, buildings or other structures for their appurtenances, and to rebuild, enlarge, alter or improve any buildings or other structures now or hereafter erected on any lands owned, held or occupied, and to mortgage, sell, lease or otherwise dispose of any

lands or interest in lands and in buildings or other structures, and any stores, shops, suites, rooms or parts of any buildings or structures at any time owned or sheld by the corporation.

- 3. To buy or otherwise acquire real estate, and to subdivide, plat and sell the same, and generally to buy, sell and deal in real and personal property of every kind and description in such manner, and upon such terms as the Board of Directors may determine.
- 4. To act as Trustee and in every kind of fiduciary capacity, and generally to do all things necessary or convenient which are incident or connected with the general business above mentioned, which a natural person might or could do.

#### ARTICLE III

The duration of the corporation shall be perpetual.

#### ARTICLE IV

The location and post office address of the registered office of the corporation shall be 312 So. Monroe, City of Spokane, County of Spokane, State of Washington.

#### ARTICLE V

The authorized capital stock of the corporation shall be Fifty Thousand Dollars (\$50,000.00), consisting of Fifty Thousand (50,000) shares of common stock, having a par value of One Dollar (\$1.00) each.

#### ARTICLE VI

The amount of paid-in capital with which the corporation will begin business is the sum of One Thousand Dollars (\$1000.00).

#### ARTICLE VII

The management of the corporation shall be vested in a Board of Directors, which shall consist of not less than three, and the number, qualifications, terms of office, manner of election, time and place of meeting, and powers and duties of the Directors shall be such as are prescribed by the By-Laws of the corporation.

#### ARTICLE VIII

The authority to make By-Laws for the corporation is hereby vested in the Board of Directors.

#### ARTICLE IX
