## ARTICLES OF INCORPORATION OF WILKINS TRUCKING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Wilkins Trucking, Inc.
