### CHRISTIAN ASSOCIATION OF NATURAL HEALING, INC.,

was filed in the office of the Secretary of State on the Twenty-eighth day of

November A. D. One Thousand Nine Hundred Sixty and
is duly recorded on Film No. 113 of Record of Domestic Corporations of the State of Idaho,
and that the said articles contain the statement of facts required by Sections 30-103, 30-1101

and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at Council, in the County of Adams,

and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men. Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

#### ARTICLES OF INCORPORATION

0F

#### CHRISTIAN ASSOCIATION OF NATURAL HEALING, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States of America, residents of the State of Idaho, and of legal age, have today voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify that this is a non-profit, religious organization, dedicated to the public good, serving in religious, educational and benevolent work according to the laws of God.

### ARTICLE I

The name of this corporation shall be: "CHRISTIAN ASSOCIATION OF NATURAL HEALING, INC."

#### ARTICLE II

The duration of this corporation shall be perpetual.

#### ARTICLE III

The location and post office address of its registered office in this State shall be Council, in Adams County, Idaho, but there may be such other subordinate and branch offices hereafter established, either within or without the State of Idaho, as the Board of Directors of this corporation may determine.

## ARTICLE IV

The objects and purposes of this corporation shall be to build, establish and provide sanitariums, hygenic restaurants, treatment rooms, to promote the sale of health foods at stores, and to establish and provide organic farms, places of worship and schools for the instruction of Natural Healing as set forth in the Bible and in the writings of Ellen G. White, a Prophetess of the Seventh Day Adventists;

2. To provide suitable places and opportunities for Christian workers to assemble and bring together all their intelligences and skills, to exchange

ideas, to counsel together, to give demonstrations, to share experiences and to lay plans whereby they can work unitedly and harmoniously in combining medical missionary work with that of proclaiming the Third Angel's message.

- 3. To practice and follow in the beliefs of those founding this corporation, namely: That the Bible is the greatest doctor book; that the use of medicines and drugs is not sanctioned in our healing profession; that this organization shall be a school of instruction in Natural Healing by use of the eight true remedies and essential requirements for perfect health, namely:

  1. Pure air; 2. Sunlight; 3. Abstinence; 4. Rest; 5. Exercise;

  6. Proper diet; 7. Use of Water; 8. Trust in Divine power.
- 4. To be and remain a non-denominational, non-profit corporation, continuing in the practices and beliefs of the "Christian Association of Natural Healing", the name used by this organization for more than four years preceding the incorporation hereof.
- 5. To accept gifts of real and personal property, donations and loans, to be used for the furtherance of the purposes and objects herein stated, and to apply for, obtain, use, enjoy and dispose of, copyrights, franchises and licenses, and to publish books, periodicals and literature of all types in furtherance of the objects and purposes of this corporation.
- 6. To acquire, hold, manage, use and enjoy, in the name of this corporation, and for the purposes and objects herein set forth, real and personal property, and to manage, sell, lease, trade or otherwise dispose of any of said property, and to do all other things which to the Directors of this corporation may seem necessary, expedient or desireable to promote the objects and purposes of this corporation, not inconsistent with the laws of the State of Idaho.

#### ARTICLE V

The government and management of the business of this corporation and the control of all of its property shall be vested in a Board of not less than three or more than one hundred Directors, who shall be members in good standing of the Christian Association of Natural Healing, Inc. Each member of the

Board of Directors shall be elected to serve for a term of three years, with the exception of the first Board of Directors who were elected at a special meeting called for the purpose of electing a Board of Directors of the Christian Association of Natural Healing, held on Sunday, October 30th, 1960, at the hour of 10 o'clock A. M. at the Whispering Pines Sanitarium on U S Highway 95, ten miles North of Council, Idaho, at which meeting a majority of the members of the Christian Association of Natural Healing present voted for and approved the following members to serve on the Board of Directors for the following terms:

FRANK W. LASHER, for a term of three (3) years; WILLIAM H. MEYERS, for a term of two (2) years;

RALPH W. DAVIS, for a term of one (1) year, or until their successors are elected and can qualify. The number of Directors may be increased or decreased from time to time as provided by the By-Laws; provided, however, that the number of Directors constituting the Board shall not be less than three or more than one hundred.

Notice of the time and place of the above election was published for three consecutive weeks immediately prior to the holding of such election in the Adams County Leader, a weekly newspaper printed and published at Council, in Adams County, Idaho, and during the same period of time a like notice was posted in a conspicious place on the building where the said election was held.
