## ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Hart, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- To conduct and carry on the business of buying, selling and transporting all kinds of grain, feed, hay and other farm produce and farm products, live stock and provisions; and to do and transact all other business necessary or incidental to the conduct and carrying on of the business aforesaid.
- The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Five Hundred (500) shares of common stock with a par value of \$100.00 per share.
