### FIRST

The name of the corporation is AgCom Financial, Inc.

### SECOND

The period of its duration is perpetual.

### THIRD

The purpose or purposes for which the corporation is organized are: Lease property, enter into leases, buy and sell property, and other related financial endeavors, and all other things incidental thereto necessary to conduct business, together with the transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Section 30-1-3.

### FOURTH

The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares of \$1.00 par value common stock.

### FIFTH

Shareholders shall have full pre-emptive rights.

### SIXTH

Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, Section 30-1-23A.

### SEVENTH

The address of the initial registered office of the corporation is 761 E. Targhee Street, St. Anthony, ID 83445, and the name of its initial registered agent at such address is Rodnie "O" Nichols.

EIGHTH
