Certificate of Incorporation of the Weston
South Side Irrigating Company, a Cor-
poration formed under and by virtue of an
act concerning Corporations enacted by the
Legislative Assembly of the Territory of Idaho
and approved January 12th. 1875, formed for
the purpose of appropriating and conducting
the waters of a stream known as Weston Creek
situated in the County of Cnida, Territory of
Idaho, for irrigating and agricultural purposes

Article 1st.

" The corporate name of this corporation is

Article 2nd.

The objects for which this corporation is formed are to appropriate and use for irrigating and agricultural purposes so much of the water of a stream known as Weston Creek, situated in the County of Cnida, Territory of Idaho. To be taken out of said Weston Creek on Section Thirteen in Township Sixteen South of Range Thirty Eight East, and about one half mile East of the Weston Grist Mill as will flow through a ditch of the following dimensions, to wit:

" Ten feet wide at the top	"
" Six feet wide at the bottom	"
" Three feet deep	"

With a fall of one and one half inches to the foot the said water to be conducted by means of the said ditch to the lands of these incorporators which are situated in what is known as the South Side, which is near the Town of Weston, in the County of Cnida in the Territory of Idaho, to be used for irrigating the lands

contained in said Gule, and for other agricultural purposes.

Article 3rd:

The amount of the Capital Stock of this corporation is ^{and} shall be the sum of Twenty Thousand dollars. And the same shall be divided into Eight hundred shares of Twenty five dollars each.

Article 4th:

This Corporation shall continue for a period of Fifty years from the 30th day of March A.D. 1880.

Article 5th:

There shall be Five Trustees of this Corporation, who shall manage the concerns of the said Corporation for the first three years after the formation of this Corporation. The names and residences of said first Five Trustees are as follows:

Article 6th:

The principal place of business of said Corporation is intended to be and shall be at the town of Weston, in the County of

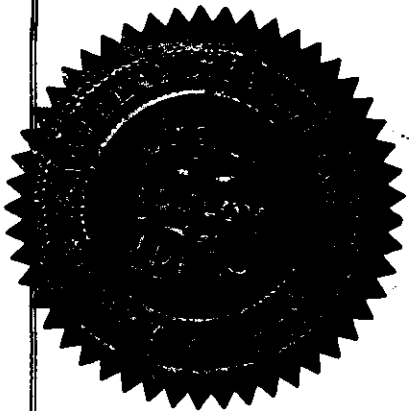
