

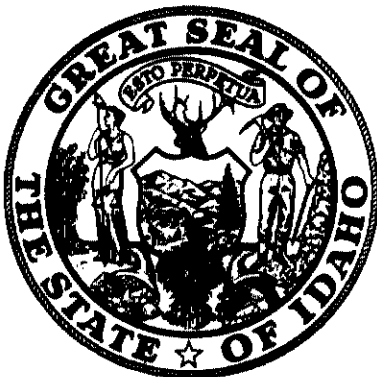
**CERTIFICATE OF INCORPORATION

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, does hereby adopt the following Articles of Incorporation for such corporation.

**ARTICLE I**

The name of the corporation shall be EconoLease, Inc.

**ARTICLE II**

The purpose for which said corporation is formed is for the transaction of any or all lawful business for which corporation's may be incorporated under the Idaho Business Corporation Act.

**ARTICLE III**

The Corporation is to have perpetual existence.

**ARTICLE IV**

The Corporation's registered office shall be EconoLease, 401 Maple Drive, Rexburg, Idaho 83440, and the name of its registered agent at such address is Lester J. Petersen.

**ARTICLE V**

The capital stock of the Corporation shall be one thousand (1,000) shares of common stock, without par value. The capital stock of the Corporation shall not be assessable.

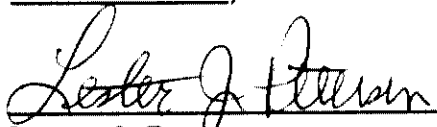

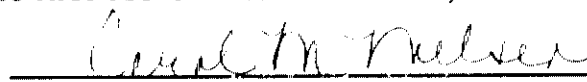
