OPTIONAL ARTICLES

Article 7: Board of Directors. All professional corporate powers shall be exercised by or under the authority of, and the business and affairs of the professional corporation managed under the direction of, its board of directors, subject to any limitation set forth in a shareholder agreement authorized under section 30-1315, Idaho Code. The number of directors constituting the initial board of directors shall be two (2), and the names and addresses of the persons to serve as director until the first annual meeting of shareholders or until their successors are elected and qualified are:

Article 8: Corporate purpose. The purpose for which this professional corporation is organized is the transaction of any and all lawful business for which such corporations may be incorporated under the provisions of Title 30, Chapter 13, of Idaho Code. The primary purpose for which this professional corporation is organized is Physical Therapy.

Article 9: Preemptive Rights. The professional corporation elects to have preemptive rights.

Article 10: Limitation of Liability. No Director shall be liable to the professional corporation or its stockholders for monetary damages for breach of fiduciary duty except liability for: (i) the amount of a financial benefit received by a director to which he is not entitled; (ii) an intentional infliction of harm on the professional corporation or the shareholders; (iii) a violation of § 30-1306, Idaho Code; or (iv) an intentional violation of criminal law.
