3. The corporation has given notice of its prospective dissolution as required by Idaho Code §30-1-87.

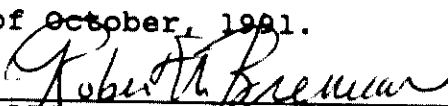
4. The corporation's known debts, obligations and liabilities have been actually paid and discharged, or adequate provision has been made therefor.

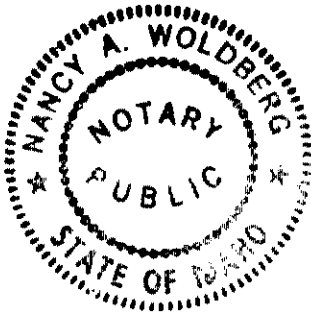
