ARTICLE OF AMENDMENT RETAR OF TO ARTICLES OF INCORPORATION OF

OAKHAVEN, INC.

> BE IT RESOLVED that Article V be amended by adding an additional paragraph thereto as follows:

> "This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code."

BE IT FURTHER RESOLVED that an additional Article be added to said Articles of Incorporation as follows:

"X. Restrictions

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code."

BE IT FURTHER RESOLVED that Article V, sub-paragraph E be amended by adding an additional sentence thereto as follows:

"Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code."
