

ARTICLES OF INCORPORATION

0F

BOWEN THEATRE COMPANY.

Arthur R. Bowen and Alice L. Bowen, of Burley, County of Cassia, bona fide residents of the State of Idaho, and George T. Pexton, C. E. Bradbury, and Mrs. Haggie Fard, all of Evanston, State of Myoming, do hereby voluntarily associate ourselves together, for the purpose of forming a corporation, under and by virtue of the laws of the State of Idaho, and to that end do execute this instrument, which when certified, signed and recorded as required by the laws of the State of Idaho, shall be and constitute the articles of incorporation of the Bowen Theatre Company of Eurley, Idaho.

And we do hereby certify;

- 1. That the name of this corporation shall be the Bowen Theatre Company.
- 2. That the purposes for which it is formed and the rights and powers under and by virtue of its organization and corporate name are; to own, maintain, operate and conduct theatres, moving picture shows, vaudevilles, concerts, and any and all other entertainments; to own, control, operate show houses, theatres, theatre buildings, music halls, and any and all other places of amusement; to charge and collect admissions and rentals; to own, hold, sell, convey, encumber, hypothecate, lease, let, real estate; to own, hold, sell convey scenery, moving picture machines and any and all other equipment of every kind or nature necessary for the operation and maintenance of theatres, picture shows or other places of smusement; to borrow money and execute therefor, its promissory notes, bills of exchange, negotiable instruments or acceptances; to employ actors and actresses and artists and generally to do any and all things necessary to be done for the proper management and control.

of picture shows, theatres, theatre buildings, music halls, social halls and places of entertainment.

- 3. That the place where its principal business is to be transacted shall be Burley, in the County of Cassia, State of Idah, and its principal office shall be located there.
- 4. That the period of duration and the term of existence of this corporation shall be fifty years from and after its incorporation unless somer dissolved by the action of the stockholders as provided by law, or by operation of law.
 - 5. That the number of directors shall be three.
- 6. That the amount of its capital stock shall be one hundred thousand dollars (\$100,000.00) which shall be divided into one thousand shares (1000) of the par value of One hundred Dollars (\$100.00) per share.
- 7. That the amount of capital stock actually subscribed is the sum of four hundred fifty-five (455) shares or Forty five thousand five hundred dollars (\$45,500.00) and the following are the names and persons by whom the same have been subscribed, together with the number of shares and the amount subscribed for.
