

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

EUCON CORPORATION



Pursuant to the provisions of Title 30, Chapter I, Idaho Code, the following Articles of Amendment to the Articles of Incorporation of EUCON CORPORATION (the "Corporation") are submitted for filing:

ARTICLE I

The name of the corporation is EUCON CORPORATION.

ARTICLE II

The text for each amendment and the provisions for implementing the amendment are as follows:

The following paragraph shall replace Article V in its entirety:

ARTICLE V

Authorized Shares

The aggregate number of shares that the corporation is authorized to issue shall be TWO HUNDRED FIFTY THOUSAND (250,000), all of which will be common voting stock with no par value. Stock may be issued by the corporation from time to time for such considerations as labor, service, money or property, real or personal, as may be fixed from time to time by the Board of Directors. The stock of the corporation shall be nonassessable.

ARTICLE III

The date the amendment was adopted was FERRUARY 22, 2002.

ARTICLE IV

The number of shares outstanding and entitled to vote was ONE HUNDRED SIXTY-TWO AND FIVE-HUNDREDTHS (162.05). All shares were voted in favor of the proposed amendment.
