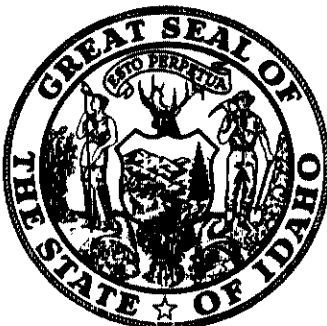
CERTIFICATE OF INCORPORATION OF

The undersigned natural persons, citizens of the United States of America and residents of the State of Idaho, acting as incorporators, hereby adopt the following articles of incorporation:

ARTICLE ONE. NAME. The name of the corporation is Cliff View Enterprises, Inc.

ARTICLE TWO. PURPOSES. The corporation is organized for the purchase, sale, ownership, maintenance, and management of commercial, residential, and rental real property, and for any allied or other lawful purpose.

ARTICLE THREE. DURATION. The period of duration of the corporation is perpetual.

ARTICLE FOUR. REGISTERED OFFICE AND REGISTERED AGENT. The address of the corporation's initial registered office in the State of Idaho is 105 E. Main Street, Lava Hot Springs, Idaho 83246, in Bannock County, and the corporation's initial registered agent at that address is August G. Berti.

ARTICLE FIVE. STOCK. The corporation is authorized to issue a total number of 2,000 shares of stock, each share having a par value of \$100.00. Such shares shall be of a single class.
