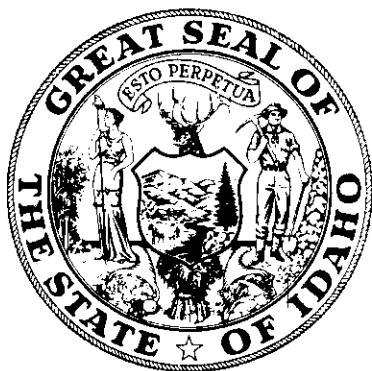

ARTICLES OF AMENDMENT
OF
AMERICAN COWBOYS, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned adopts and verifies the following Articles of Amendment to the Articles of Incorporation of AMERICAN COWBOYS, INC.:

1. The name of the corporation under which it was incorporated on July 5, 1983 was AMERICAN COWBOYS, INC.
2. The following Amendments to the Articles of Incorporation were adopted by the Shareholders of the corporation on February 23, 1984:

ARTICLE I
NAME

The name of the corporation shall be AMERICAN PRODUCTIONS, INC.

ARTICLE VIII


