CERTIFICATE OF LIMITED PARTNERSHIP

CALLISTER DAIRY, LTD., LIMITED PARTNERSHIP

Pursuant to the provisions of the Uniform Limited Partnership Act of the State of Idaho, the undersigned hereto form a limited partnership and do desire to file a Certificate of Limited Partnership and do hereby certify as follows:

(1) The name of the partnership is Callister Dairy, Ltd., Limited Partnership.

(2) The purpose of the partnership is the acquisition, ownership, development, management, rental, sales and operation of real and personal property, equipment, livestock and machinery of a dairy farm and a ranching and farming operation.

(3) The principal place of business of the partnership is HC 65, Box 1014, Howe, Idaho 83244.

The registered agent for the limited partnership is Don O. Callister, HC 65, Box 1014, Howe, Idaho 83244.

(4) The name and place of residence of each general partner interested in the partnership is as follows:

(6) The term for which the partnership is to exist is from January 1, 1991, and to continue indefinitely until terminated, as provided in the partnership agreement.

(7) The amount of cash and description and agreed value of other property contributed to each limited partner are as follows:

Agreed value of the properties to be contributed is \$413,830.00.

Contributed as a general partner by Don O. Callister -- \$25,000.00.

Contributed as a limited partner by Don O. Callister and Kristine G. Callister - \$77,400.00.

Contributed as a limited partner by Rulon J. Callister and Margaret S. Callister - \$311,420.00.

Description of property:

All of the livestock, machinery, equipment, utensils and tools heretofore utilized by the partners in the operation of the Callister Dairy Farms with a total agreed value of \$413,700.00.

A more particular description marked Exhibit "A" is attached hereto and made a part hereof.

(8) No time is agreed upon, with respect to the return of any contributions made by any of the limited partners.

(9) The share of profits, or other compensation by way of income which each limited partner shall receive, by reason of their contribution, is as follows:

Don and Kristine G. Callister -- 25%

Rulon J. and Margaret S. Callister -- 75%

(10) A limited partner shall have rights of assignment and the right to substitute limited partners, as provided by the law.

(11) Additional limited partners may be admitted to the partnership, provided, however, that partners possessing an aggregate interest of more than 66-2/3% of the capital of the partnership consent to such admission.

(12) No right is given to any limited partner to priority over other limited partners, as to return of contributions or extra compensation by way of income.

(13) On the death, retirement or incapacity of the general partner, the business may be continued by a substitute general partner.

(14) No right is given to a limited partner to demand and receive property, other than cash, in return for their contribution.

WHEREFORE, the partners of Callister Dairy Farms, Ltd., Limited Partnership, executed this Certificate of Limited Partnership on this 15th day of May, 1991.
