ARTICLES OF AMENDMENT

KNOW ALL MEN BY THESE PRESENTS: That Virgil Wicks, President, and Ilene Combs, Secretary, of the above named corporation, respectively, represent:

That the above named corporation was incorporated under the laws of the State of Idaho on the 15th day of May, 1961.

That on the 13 day of September, 1969, at a special meeting called for the purpose, among other things, of amending the Articles of Incorporation of said corporation, as provided for in §31-46 and §31-47, Idaho Code, and at which special meeting all officers and directors of Snake River Rodeo Association, Incorporated, entitled to vote, were present in person and participated at said meeting, and executed a Waiver of any other or formal notice of said meeting, whereupon the following Resolution was duly moved and seconded:

" BE IT RESOLVED that ARTICLE I of the Articles of Incorporation of Snake River Rodeo Association, Incorporated., an Idaho corporation, to-wit:

' ARTICLE I. The name of the corporation shall be "Snake River Rodeo Association, Incorporated" '

and in lieu thereof Article I should be as follows:

ARTICLE I.

The name of the corporation shall be

INTERMOUNTAIN RODEO ASSOCIATION, INC. '

That upon being put to a vote the aforementioned Resolution was passed

unanimously, and all present and entitled to vote voting in the affirmative, and the President and Secretary were advised to issue their certificate to the Secretary of State of the State of Idaho for the purpose of amending the Articles of Incorporation in compliance with the Resolution.






VIRGIL WICKS and ILENE COMBS, being first duly sworn upon oath, each for himself/herself and not one for the other, deposes and says:
