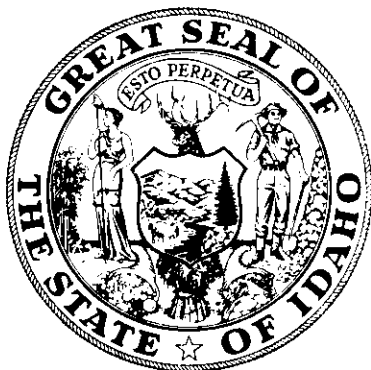

ARTICLES OF AMENDMENT

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, a natural person of full age, citizen and resident of the United States of America, and the record owner of all outstanding and issued shares of stock of GANO-TOOLSON & ASSOCIATES INSURANCE, INC., an Idaho Corporation, does hereby certify the following as Articles of Amendment of the original Articles of Incorporation of said corporation.

ARTICLE I.

The name of the Corporation, prior to amendment, is GANO-TOOLSON & ASSOCIATES INSURANCE, INC. The name of the Corporation after amendment shall be GANO & ASSOCIATES INSURANCE, INC.

ARTICLE II.

The amendment adopted to these Articles are as follows:

That this Corporation adopt Articles of Amendment, a copy of which is attached hereto as Exhibit "A". The purpose of such Articles shall be to amend the existing Articles of Incorporation of said Corporation to provide for a change of corporate name from Gano-Toolson & Associates Insurance, Inc., to Gano & Associates Insurance, Inc.




