I.

The name of the corporation is the ST. MARIES GUN CLUB, INC.

II.

The corporation is a non-profit corporation.

III.

The period of its duration is perpetual.

IV.

The purpose of the corporation is to own, operate, and maintain, for the benefit of its members and the public at large, a shotgun shooting range and all operations related thereto at no profit to the corporation, its directors, officers or members.

v.

The corporation shall have members, but the management of the affairs of the corporation shall be vested in a board of directors.

VI.
